Welcome to <u>www.labtician.com</u>. These terms and conditions (the "Terms") apply to your access and use of <u>www.labtician.com</u>, as well as any other digital property (the "Site") that Labtician Ophthalmics, Inc. ("Labtician," "we," "us," or "our") offers in conjunction with our products and services (the "Services").

By accessing or using the Site or Services in any manner (automated or otherwise), you acknowledge that you: (a) have read, understand, and agree to be bound by these Terms and Labtician's <u>Privacy Policy</u>, which is incorporated into these Terms by this reference; (b) are at least 18 years old (or have reached the age of majority in the jurisdiction where you reside); and (c) have full power, capacity, and authority to accept these Terms.

Labtician may, at any time and in our sole discretion, modify, add to, or remove portions or all of these Terms (collectively, "Changes"). It is your responsibility to check these Terms periodically for Changes. Changes are effective immediately upon notice to you, and such notice may be given by any means, including posting on the Site or by email. Any use of the Site or Services by you after such notice means that you accept and agree to be bound by the Changes.

I. About Labtician and These Terms

Labtician manufactures, distributes, and sells a range of ophthalmic and oculoplastic product lines, including surgical eye care products and equipment, which we make available through the Site to both "Clinics" (which means medical professionals such as personal eye doctors and professional staff) and patients providing access to his or her prescription(s) and/or medical information "Patients". Through the Site, Labtician also provides other services including "filling" certain medical prescriptions.

Labtician offers a secure portal for Clinics ("Clinic Portal"), as well as a secure portal for Patients ("Patient Portal"), to which these Terms apply. Additional terms and conditions (including other agreements, guidelines, or rules) may apply to your use of certain Content (as defined below), Services, and/or Site features, including additional terms and conditions for the Clinic Portal and the Patient Portal (collectively, the "Portals"). For the avoidance of doubt, in the event of any conflict between these Terms and such additional terms and conditions or between these Terms and any term of any specific, written agreement that both you and Labtician have executed, the terms and conditions of such additional terms and conditions or of such specific, written agreement shall prevail, but only with respect to the scope and subject matter of such additional terms and conditions or of such specific, written agreement.

II. Use and Submission of Content

In some cases, a Patient may provide partial or incorrect information and Labtician will still be able to retrieve relevant Personal Health Information. Patients and Clinics acknowledge that use of such Personal Health Information includes filling prescriptions or otherwise providing Services to Patients and Clinics. Patients and Clinics agree that Labtician shall be entitled to rely on the accuracy of any provide or derived information and has not affirmative obligation to independently verify such information.
